To see if you are able to qualify to enter directly onto the level 3 course, visit www.aat.org.uk and in the search box enter skills test, this will give you 30 questions and will at the end tell you what the appropriate level for your study is. You must provide proof of the results to the course leader, when enquiring.

On completion of the course you should be able to get a job as an Accounts Assistant, Purchase or Sales ledger clerk, or a bookkeeper.

There is no fee remission for this course

If you have to pay the full costs for the course they are as follows:

The course fees will include your membership to AAT, all materials for the course and all exam fees for 2 sittings only, (should you not pass any of the exams then the resit costs would have to be paid for by yourself).

- You could pay by Standing Order. The college would require a deposit.
